AUDIT FINDINGS

Narrative:

The notifications of the audit were posted in the facility six weeks prior to the on-site visit of the auditor and evidenced by photos of the notices posted throughout the facility sent to the auditor via email as soon as they were posted. Areas where the notices were posted included: medical, school, each housing unit, administration, gymnasium, and intake. The Pre-Audit Questionnaire was completed and submitted using the Online Audit System (OAS) prior to the on-site portion of the audit. There were several communications (electronic mail and telephone calls) between the auditor and facility staff in reference to the documentation and the audit process. The audit of Prince William Juvenile Detention Center took place on the dates of August 14th and 15th, 2019. The audit team arrived at the facility at 8:30 a.m. on August 14, 2019. An entrance conference was held prior to touring the facility and beginning interviews. Present at the entrance conference were the Superintendent, Assistant Superintendents and the audit team. A complete facility tour was conducted. During the tour, staff members were observed to be posted to provide for optimal supervision of the residents. During the tour, this auditor observed PREA audit notices, PREA signs and informative postings on the multiple ways residents and staff could report sexual abuse and harassment. The postings included addresses and telephone numbers. During the tour and throughout the on-site portion of the audit, the cross-gender announcements were made as staff of the opposite gender entered housing units housing residents of the opposite gender. After touring the facility and observing residents on the housing unit, at recreation, at visitation, receiving professional visits, at medical and in intake meeting with staff, the auditor began interviewing residents and staff in the facility using the required interview protocols and discussions. Thirteen randomly selected staff were interviewed using the interview protocols. Staff interviews covered staff from all shifts. 18 specialized staff interviews were conducted; which included medical and mental health, investigations, intermediate and higher-level facility staff, administrative staff, members of the incident review team, designated staff charged with monitoring for retaliation, intake staff, and staff that perform screening for risk of victimization and abusiveness. 28 of the 28 residents assigned to the facility were interviewed. The files of every resident assigned to the facility were reviewed by the auditor to ensure the reception of PREA related intake and orientation information, as well as the provision of the screening and risk/vulnerability assessments. Resident education materials including resident sign-in sheets were reviewed to ensure the delivery of the required PREA related education materials within ten days of intake. The Superintendent (Agency Head), and both Assistant Superintendents, one of which serves as the PREA Coordinator, were interviewed. The audit team departed the facility at 7:30 p.m. The audit team arrived at the facility the next morning at 8:00 a.m. to complete interviews, review files, video of unannounced rounds and other related documentation. Documentation reviewed included, staff training files, personnel files, review of backgrounds checks, and review of mandatory PREA related disclosure documentation, a random sampling of facility logs, shift documentation, policies and procedures, video, training records/logs and curriculum. Prior to the on-site portion of the audit, during the on-site portion of the audit, and after its conclusion, additional documentation was provided as requested. At the conclusion of the document review and the completion of all interviews an exit conference was held Superintendent and both Assistant Superintendents at 3:30 p.m. on August 15, 2019.

AUDIT FINDINGS

Facility Characteristics:

Prince William County Juvenile Detention Center (PWC JDC) is a 72-bed, co-ed detention facility designed and licensed to provide secure detention for juvenile 10-17 years of age. The facility is made up of one large building with no buildings adjacent to it. Nearby are additional County buildings and services. The mission of the facility is: "To protect the community, staff and youth we serve; provide structured programs in a humane environment and promote healthy emotional, educational and social development".

PWC JDC opened for operations in 1979. The facility is located in the hub of Prince William County, Virginia. The facility is part of the Residential Services Division of the Prince William County Department of Social Services. The facility provides services to Prince William County, Manassas City and Manassas Park. The facility has six housing units. All units have two private showers and two toilets. Each individual sleeping room is equipped with a sink and toilet.

Residents receive educational services, mental and somatic health services, recreational programming, behavior management, treatment services, and family engagement and visitation. The residents have access to outside and indoor recreation. Residents are primarily placed in secure detention pending adjudication and disposition from a court with jurisdiction of the charges. Following disposition, a small percentage of Residents are detained pending transport to other correctional centers or specialized Residential programs. Residents in the facility who are assigned to the Community Placement Program may receive crisis intervention, substance abuse, aggression replacement therapy, sex offender treatment, counseling and educational services while in custody at the center.

All residents participate in the center's behavior management program (the Level System) which rewards positive prosocial behavior and progressively addresses negative behaviors. Residents are afforded due process and have unrestricted access to the Resident Grievance Procedure.

A structured daily routine provides consistency and predictability for residents and staff. The daily schedule maps out all facets of the day including meals, school, treatment services, health care, physical exercise, family visitation and bedtime. Residents enjoy recreational activities on the housing units, in the indoor gym and outdoor recreation areas. Activities include a variety of sports that include basketball, volleyball, weight training, yoga, video games, arts and crafts, and football. Residents also have access to television, board games, reading, cards, and puzzles. A typical day for a resident involves hygiene, meals, school, recreation, structured physical and leisure activities and visits from family. In addition, participation in required activities limits the opportunity for residents to act out due to boredom or lack of engagement.

While medical services are provided on site, when an emergency problem arises the problem is identified and the nurse coordinates care with Sentara Hospital Woodbridge.

The facility is licensed and accredited by the Virginia Department of Juvenile Justice. Security and supervision of residents are heightened and supplemented by video cameras which are located throughout the interior and exterior of the facility; the surveillance system permits for recording and playback which support the investigatory process.

During the on-site portion of the audit, residents were observed receiving various services, participating in large-muscle exercise during indoor and outdoor recreation, receiving visits, engaging in structured

activities on the units, and group and individual counseling. Residents were engaging and participatory in their programming. The residential staff were observed by the auditor to be properly posted and observant in the monitoring of resident across all shifts. The facility was clean and well maintained. The housing units were decorated with artwork by the residents and murals completed by residents and community-based volunteers.

115.311	<p>Zero tolerance of sexual abuse and sexual harassment; PREA coordinator</p> <p>Auditor Overall Determination: Meets Standard</p> <p>Auditor Discussion</p> <p>The agency’s Zero Tolerance Policy is addressed in the policy manual Chapter 100, Number 100, pp. 1 - 3: Mission, Vision and Philosophy and Chapter 300 page 300, pp. 1 – 12: Prison Rape Elimination Act (PREA). The Mission, Vision and Philosophy policy state’s the agency’s Zero Tolerance for all forms of sexual abuse and sexual harassment. The PREA policy details the agency’s approach to implementing the Federal PREA standards and includes the agency’s strategies and response to reduce and prevent sexual abuse and sexual harassment of residents. The policy prohibits all forms of sexual abuse and sexual harassment and reiterates the agency’s zero tolerance policy. The policy provides definitions of prohibited behaviors. In addition to outlining the agency’s approach to preventing, detecting, and responding to sexual abuse and sexual harassment, the policy provides sanctions for those found to have participated in prohibited behaviors. The agency presented the organizational chart which shows the organizational structure and the position of the PREA Coordinator (Assistant Superintendent). Because the agency has only one juvenile detention center, there is no PREA Compliance Manager. The PREA Coordinator (Assistant Superintendent) reports directly to the Superintendent. 	<p data-bbox="252 170 896 203">Auditor Overall Determination: Meets Standard</p> <p data-bbox="252 248 523 282">Auditor Discussion</p> <p data-bbox="252 327 1485 1559"> The agency presented the current Staffing Plan and current and previous Facility Staffing, Logistics Assessments which detail the process by which current staffing, possible changes to staffing, and future staffing determinations are analyzed and made with consideration given to physical plant and resident population. Additionally, the PREA Coordinator and Superintendent confirm that during the review, due weight and consideration is given to the following factors: : (1) generally accepted juvenile detention and correctional/secure residential practices; (2) any judicial findings of inadequacy; (3) any findings of inadequacy from Federal investigative agencies; (4) any findings of inadequacy from internal or external oversight bodies; (5) all components of the facility’s physical plant (including “blind spots” or areas where staff or residents may be isolated; (6) the composition of the resident population; (7) the number and placement of supervisory staff; (8) institution programs occurring on a particular shift; (9) any applicable State or local laws, regulations, or standards; (10) the prevalence of substantiated and unsubstantiated incidents of sexual abuse; and (11) any other relevant factors. Further, the facility is required to maintain a staff to resident ration of 1:8 during waking hours and 1:16 during sleeping hours. Only security staffs are included in the staffing ratios. During the past twelve months, there have been no deviations from the staffing plan. In addition to direct supervision of residents, the facility is equipped with a video monitoring system which supplements supervision by staff and supports efforts to comply with the PREA standards to ensure a safe environment for all. The auditor was able to observe staff postings during waking and sleeping hours, as well as the use of the camera system to supplement supervision and monitoring; including playback of data and captured video. Policy 300, Number 301 (Unannounced Rounds) requires intermediate and higher-level staff to conduct unannounced rounds to identify and deter staff sexual abuse and sexual harassment. Rounds are conducted across all shifts. The rounds are documented on the unannounced monitoring report. A physical review of documentation, video of unannounced rounds and various staff interviews confirmed the practice of unannounced rounds. Policy 300, number 301 prohibits staff from alerting others the unannounced rounds are taking place. 	<p>Policy 300 Chapter 302 (Limits to Cross-gender Viewing and Searches) outlines that cross-gender searches are prohibited; this includes both pat searches and strip searches. Staffs who perform pat downs and strip searches are trained in how to conduct searches of transgender and intersex residents in a professional and respectful manner and in the least intrusive manner possible while ensuring the safety and security of the facility. Additionally, this policy prohibits physically examining a transgender or intersex resident for the sole purpose of determining the resident's genital status. The policy establishes that cavity searches may only be conducted by medical professionals. During the past 12 months, there were no cross-gender strip or visual body cavity searches and no cross-gender pat-down searches of residents. Interviews with residents and staff confirm compliance with agency policy and procedures regarding searches. Policy 300 Chapter 302 requires staff of the opposite gender of residents on a particular housing unit to announce themselves prior to entering the housing unit. To further ensure compliance with policy and this standard, a sign is posted outside the door of each housing unit reminding staff of the requirement to make the cross-gender announcement prior to entering the housing unit. Observations made by the auditor during the on-site portion of the audit and interviews with residents and staff confirmed the practice of the cross-gender announcement. Policy 300 Chapter 302 ensures the provision of privacy for residents when they may be changing clothes, showering and performing bodily functions. 	<p>Auditor Discussion</p> <p>relevant review period)</p> <p>Policy 300 Chapter 300 (Prison Rape Elimination Act) requires that the agency takes the appropriate steps to ensure that residents with disabilities have an equal opportunity to participate in or benefit from all aspects of the agency’s efforts to prevent, detect, and respond to sexual abuse and sexual harassment. Additionally, residents requiring the assistance of an interpreter will be provided such assistance through the use of bi-lingual staff and the use of a contract with Language Line. The policy also prohibits the use of resident interpreters, resident readers or other types of resident assistants. Various forms are available to youth in both English and Spanish and PREA posters and information is also posted in English and Spanish throughout the agency. The agency has had no residents with disabilities in the last 12 months. Criminal background checks will be conducted on all employees every 5 years.</p> <p>All applicants whether applying for employment or applying for a promotional opportunity will be screened for previous misconduct. 	<p>Prince William County Juvenile Detention Center has not acquired a new facility agency or made any substantial expansions or modifications to the existing facility since August 20, 2012. The agency has installed and made updates to the video monitoring system, electronic surveillance system, or other monitoring technology since August 20, 2012. The agency has digital cameras which have the capacity to store and retain data. The system supplements supervision and monitoring and aids in the completion of investigation into allegations of abuse and or misconduct. 	<p>The facility only conducts administrative investigations related to sexual abuse investigations. Virginia Department of Juvenile Justice also investigates allegations of sexual abuse. The Prince William County Sheriff's Office has the responsibility for conducting all criminal investigations including those regarding sexual abuse. The Prince William County Sheriff's Office follows a uniform evidence protocol that is developmentally appropriate for youth when conducting sexual abuse investigations. A Memorandum of Understanding between the facility and Sheriff's Office was presented for review and specifies roles of each of the parties. The PWJDC Facility Operating Procedure 300 requires that all residents who experience sexual abuse in the facility have access to forensic medical examinations without financial cost to the victim. The procedure also requires that where possible the forensic examinations are conducted by a Sexual Assault Forensic Examiner (SAFE) or a Sexual Assault Nurse Examiner (SANE). When a SAFE or SANE is not available a qualified medical practitioner performs forensic medical examinations. Efforts to provide access to a SAFE or SANE are documented by the facility. The facility utilizes Sentara Hospital Woodbridge for medical treatment of residents. There have been no forensic examinations conducted in the past 12 months.</p> <p>The facility attempts to make a victim advocate from a rape crisis center available to the victim, in person or by other means. This is supported by the facility's relationship through a Memorandum of with the ACTS Sexual Assault Services which was confirmed by the presentation and review of the agreement between PWJDC and ACTS. The agreement verified that ACTS would provide victim advocacy to residents of the facility who experience sexual abuse. The PWJDC Standard Operating Procedure also requires that if and when a rape crisis center is not able to provide victim advocacy services that facility shall make the services available by a qualified agency staff member. 	<p>The PWJDC Facility Operating Procedure Chapter 300 directs the referrals of allegations for investigations and ensures that all allegations of sexual abuse and sexual harassment are administratively and or criminally investigated. Allegations of sexual abuse or sexual harassment are referred for investigation to an agency with the legal authority to conduct criminal investigations, unless the allegation does not involve potentially criminal behavior. The agency documents all referrals of allegations of sexual abuse or sexual harassment for criminal investigation. In the past 12 months, there were five allegations of sexual abuse received by the facility; none of the five were referred for criminal investigation. Additionally, the agency's policy regarding the referral of allegations of sexual abuse or sexual harassment for a criminal investigation is published on the agency website or made publicly available via other means. Employees who are reassigned from facilities housing the opposite gender are given additional training. The facility has 74 staff that may have contact with residents, who were trained or retrained on the PREA requirements. Between trainings the agency provides employees who may have contact with residents with refresher information about current policies regarding sexual abuse and harassment through shift briefings and regular meetings. Additionally, staff carry first responder cards and are issued copies of a handheld standards booklet. The frequency with which employees who may have contact with residents receive refresher training on PREA requirements is annually and more frequently as needed. Resident education is accessible to all residents, including residents who are limited English proficient and those residents who may be deaf, visually impaired or otherwise disabled. During the intake process, staff read and review the zero-tolerance policy and information on how to recognize and report sexual abuse and sexual harassment with each resident. After providing the residents with the required information related to the zero-tolerance policy, staff and the residents sign the orientation documentation; staff acknowledge providing the information and residents acknowledge that the information was received and understood. Additional resident education is provided to each resident within ten days of the intake process. A total of 379 residents admitted to the facility in the past 12 months received information at intake. Of those 379, 303 residents received comprehensive age-appropriate education on their rights to be free from sexual abuse and sexual harassment, from retaliation for reporting such incidents, and on agency policies and procedures for responding to such incidents within 10 days of intake. Documentation of the residents' and staff's signatures is maintained by the facility. Further confirmation of resident education was received during resident and staff interviews. The PREA information is presented in a manner that is accessible to all residents. During the facility tour the auditor observed the presence of PREA posters and reporting instructions posted throughout the facility. 	<p>The PWJDC Facility Operating Procedure requires that the agency has established procedures allowing for multiple internal ways for residents to report privately to agency officials about: sexual abuse; sexual harassment; retaliation by other residents or staff for reporting sexual abuse or sexual harassment; and staff neglect or other violations of responsibilities that may have contributed to such incidents. At PWJDC residents are able to report allegations verbally, in writing, and through third parties. Residents may report allegations anonymously. A resident may complete a counseling request or initiate a grievance; residents have access to writing materials and tools to document any such report. Residents repeatedly reported to this auditor that they may ask to speak to the PREA Coordinator or any administrator. Additionally, residents have access to the resident phone system where they are able to call into the PREA Hotline phone. They may call the child abuse hotline, Prince WM County Department of Social Services, ACTS, and/or the Office of the Public Defender. Residents reported numerous ways to report abuse. The Standard Operating Procedure mandates that staff accept reports of sexual abuse and sexual harassment made verbally, in writing, anonymously and from third parties. All verbal reports must be documented promptly by staff and immediately reported to the Administrator or Assistant Administrator. PWJDC does not detain residents for civil immigration purposes. As mandated reporters, staff are required to report sexual abuse and sexual harassment of residents; staff may privately report directly to any administrator. Staff may also make private reports to human resources. Residents receive reporting information at intake, this information is also found in the resident handbook. Reporting information is posted throughout the facility and adjacent to the telephones to assist residents in making reports using the telephone. Interviews with staff and residents support an understanding of the process including the multiple ways residents may report allegations of sexual abuse or sexual harassment as well as ways staff may privately report allegations of abuse. 	<p>The PWJDC Facility Procedure PREA Policy and Youth Grievance Policy provide the administrative process for dealing with resident grievances regarding sexual abuse. Residents are provided information as to how to file a grievance during the intake process and again within 10 days of intake. The PREA Coordinator reports and the Grievance Policy states that there is no time limit for a resident to submit a grievance regarding an allegation of sexual abuse. PWJDC shall not require any resident to use an informal grievance process, or otherwise to attempt to resolve with staff, an alleged incident of sexual abuse. Further, the agency allows for a resident to submit a grievance alleging sexual abuse without submitting it to the staff member who is the subject of the complaint. Decisions on the merits of any grievance or portion of a grievance alleging sexual abuse is made within 90 days of the filing of the grievance. Additionally, policy the Standard Operating Procedure permits third parties, including fellow residents, staff members, family members, attorneys, and outside advocates, to assist residents in filing requests for administrative remedies relating to allegations of sexual abuse, and to file such requests on behalf of residents. The Procedure requires that if the resident declines to have third-party assistance in filing a grievance alleging sexual abuse, the agency documents a resident's decision to decline. Further, policy allows parents or legal guardians of residents to file a grievance alleging sexual abuse, including appeals, on behalf of such resident, regardless of whether or not the resident agrees to having the grievance filed on their behalf. There have been no grievances alleging sexual abuse filed by residents in the past 12 months in which the resident declined third-party assistance, containing documentation of a resident's decision to decline. As it relates to the filing of emergency grievances alleging substantial risk of imminent sexual abuse, policy outlines the established procedures. This policy requires an initial response within 8 hours after filing an emergency grievance alleging substantial risk of sexual abuse and requires the agency to issue a final decision be issued within five days. Lastly, policy and the Standard Operating Procedure limits the ability to discipline a resident for filing a grievance alleging sexual abuse to occasions where the agency demonstrates that the resident filed the grievance in bad faith. The policy also requires the facility to enable reasonable communication between residents and these organizations in as confidential manner as possible. The facility informs residents, prior to giving them access to outside support services, the extent to which such communication will be monitored. The facility informs residents prior to giving them access to outside support services, of the mandatory reporting rules governing privacy, confidentiality, and/or privilege that apply for disclosures of sexual abuse made to outside victim advocates, including any limits to confidentiality under relevant Federal, State or local law. The agency maintains memoranda of agreements with community service providers (ACTS) that are able to provide residents with emotional support services related to sexual abuse. The facility maintains copies of the memorandum of agreement. The facility provides residents with reasonable and confidential access to their attorneys or other legal representation. Residents are able to call, write and visit with parents and legal guardians. Resident interviews confirmed that they were aware of the telephone numbers and addresses and how to contact outside support services. While the answers in the resident interview protocol varied related to service provision from outside support, residents understood that they would be helped and that the help would be confidential and supportive in nature. Staff and resident interviews confirmed that residents have reasonable access and that access is provided in as confidential a manner as possible. Interviews with residents and staff confirm that residents have access to their attorneys, other legal representation, as well as parents and legal guardians. If a juvenile court retains jurisdiction over the alleged victim, the facility head or designee shall also report the allegation to the juvenile's attorney or other legal representative of record within 14 days of receiving the allegation. Other than to the extent necessary to make treatment, investigatory, or security and management decisions; agency policy prohibits staff from disclosing or revealing information regarding an allegation of abuse to anyone other than designated supervisors, officials, and designated State or local service agencies.
