### Incidents

**Fatal Crash Investigation** – On April 14 at 8:02PM, officers responded to the 3500 block of Cranmer Mews in Woodbridge (22193) to investigate a single vehicle crash. The investigation revealed the driver of a 2018 Chevrolet Cruze was traveling westbound on Dale Blvd. approaching Cherrydale Dr. at a high rate of speed, when the driver crossed over the median into the eastbound lanes and struck a guardrail. The vehicle continued through the intersection before driving down into an embankment on Cranmer Mews. The vehicle then struck a tree, flipped over and came to rest upside down. The driver of the vehicle, and only occupant of the Chevrolet, was pronounced deceased at the scene. Speed and impairment appear to be factors in the crash. **Investigators with the Crash Investigation Unit are asking anyone who may have witnessed this crash to contact police.** The investigation continues.

***Identified:***

The deceased driver of the 2018 Chevrolet Cruze was identified as Lavone Rasheed **RICHARDSON-CROSBY**, 34, of no fixed address

**Armed Robbery** – On April 14 at 1:59AM, officers responded to the Meridian Bay Apartments located in the 3000 block of Fox Lair Dr. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victims, a 16-year-old male juvenile and an 18-year-old man, were approached by two unknown men. During the encounter, the men brandished firearms and demanded the victim's property before fleeing in a vehicle. No injuries were reported. A pair of shoes, an undisclosed amount of money, and a cell phone were reported missing.

**Armed Robbery** – On April 12 at 5:43PM, officers responded to the Tobacco King and Vape located at 1330 Old Bridge Rd. in Woodbridge (22192) to investigate a robbery. The investigation revealed two men approached the service counter and one of the men grabbed items from an employee while the other suspect destroyed merchandise. Both men fled to the parking lot where they were joined by a third suspect and when an employee attempted to follow them, one of the suspects brandished a firearm. No injuries were reported. Vape products were reported missing. The suspects, possibly juveniles, were described as a black male wearing a white hooded sweatshirt, a black male wearing a grey hooded sweatshirt, and a black male wearing a black hooded sweatshirt, and all were wearing face masks.

**Reckless Handling of a Firearm** – On April 13 at 8:51PM, officers responded to the area of Powells Creek Blvd. and River Ridge Blvd. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed the victim, a 43-year-old woman, was stopped at the above intersection waiting for a group of males to cross the street when a Honda sedan abruptly pulled around her. The Honda then quickly stopped in the intersection where gunfire was then exchanged between the occupants of the Honda and the group of males on foot. The victim's vehicle was struck before she could drive out of the area and contact the police. No injuries or additional property damage were reported. Shell casings were located in the roadway. **This incident does not appear to be random.**

**Strong-Arm Robbery** – On April 13 at 4:56PM, officers responded to the Rolling Brook Apartments located in the 1800 block of Sugar Hill Dr. in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 42-year-old man, arranged to sell a phone to an individual over a social media app near the community center. During the encounter, the suspect grabbed the phone from the victim and fled to a nearby vehicle before driving out of the area. No injuries were reported.

A black male, approximately 20 years old, 5'10", and 150lbs.

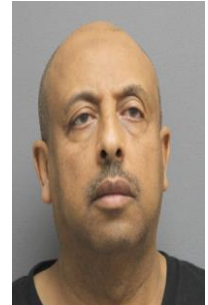

## Arrests

**Abduction With Intent to Defile | Sexual Assault** – On April 12 at 10:27AM, officers responded to Somerset Pointe Apartments located in the 14700 block of Deming Dr. in Gainesville (20155) to investigate a sexual assault. The investigation revealed the victim, an adult woman, was approached by an unknown man, later identified as the accused, and the two went to the accused’s apartment where the accused prevented her from leaving and inappropriately touched her. The victim eventually left the apartment and reported the incident to family member who contacted the police. Following the investigation, the accused, identified as Teodros **GIRMA**, was arrested.

**Threats by Electronic Means** – On April 13 at 8:17PM, officers responded to the Prince William County Community Services Board (CSB) located at 7969 Ashton Ave. in Manassas (20109) to investigate a threat made towards CSB. The investigation revealed an individual, later identified as the accused, called CSB and made threats towards the building and the staff. While investigating the incident, officers identified the accused and determined the threats to the facility were not credible. Following the investigation, officers obtained arrest warrants for the accused, identified as Joseph Aaron **EMERSON**, who was arrested in Waynesboro later that evening.

**Strangulation** – On April 12 at 8:56PM, officers responded to the Longhorn Steakhouse located at 9695 Liberia Ave. in Manassas (20110) to investigate an assault. The investigation revealed an employee and a patron, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused pushed the victim before grabbing his neck. Eventually the parties separated, and the police were contacted. Minor injuries were reported. Following the investigation, the accused, identified as Gregory Scott **BOROS**, was arrested.

**Strangulation (Domestic)** – On April 12 at 7:04PM, officers responded to a residence located in the 10100 block of Quayle Ct. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 10-year-old girl and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused grabbed the victim and strangled her before the parties temporarily separated. During a second verbal altercation, another family member, identified as a 37-year-old woman, attempted to intervene and the accused pushed her before police arrived at the residence and separated all of the parties. The juvenile victim reported minor injuries. Following the investigation, the accused, identified as a **17-year-old male juvenile**, was arrested.

**Attempted Residential Burglary** – On April 12 at 6:42PM, officers responded to the Bell Stonebridge Apartments located in the 14700 block of River Walk Way in Woodbridge (22191) to investigate an attempted burglary. The investigation revealed the occupant of an apartment heard loud noises at the door and upon checking the surveillance footage, they observed a masked individual, later identified as the accused, kicked the front door several times before fleeing the apartment building. Responding officers located the accused nearby where he was detained without incident. No entry was made into the apartment. Following the investigation, officers sought petitions against the accused, identified as a **15-year-old male juvenile**. After consultation with Juvenile Court Services, the case resulted in formal action and will be handled through the court process at a later date.
