Incidents

Stabbing Investigation - On April 23 at 4:55AM, officers responded to investigate a stabbing that was reported to have occurred in the Dillingham Square shopping center located at 12400 Dillingham Sq. in Woodbridge (22192) between 6:00PM and 7:00PM on April 22. The investigation revealed the victim, a 16-year-old male juvenile, was involved in a verbal altercation before being stabbed in the upper body. The victim was treated at an area hospital where police were contacted. The victim refused to further cooperate with officers regarding the incident, which **does not appear to be random.**

Abduction - On April 21 at 10:30PM, officers responded to a residence located in the 2700 block of Burrough Hill Ln. in Woodbridge (22191) to investigate an abduction. The investigation revealed the victim, a 23-year-old woman, and her landlord, identified as the accused, were involved in a verbal altercation. At one point, the accused physically prevented the victim from leaving the home. After an extended period of time, the victim was able to exit the residence and contacted the police. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Elith Samuel **PARADA**, who remains wanted.

Vandalism on School Grounds – On April 22 at 8:36AM, the School Resource Officer (SRO) was notified of vandalism that was reported to have occurred at both Benton Middle School, located at 7411 Hoadly Rd., and neighboring Coles Elementary School, located at 7405 Hoadly Rd., in Manassas (20112) between 12:30AM and 1:00AM on April 20. The investigation revealed swastikas and vulgar language were found on several traffic cones and light poles near the middle school and playground equipment at the elementary school. No additional property damage was reported. Surveillance footage showed several unidentifiable individuals around both schools during the above timeframe. The writings and images did not cause permanent damage and were removed prior to student arrival.

Arrests

Aggravated Malicious Wounding | Felony Hit & Run – On April 21 at 10:10PM, crash investigators responded to the Red Roof Inn located at 10610 Automotive Dr in Manassas (20109) to investigate a hit & run crash. The investigation revealed the victim, a 51-year-old man, and an acquaintance, identified as the accused, were involved in a physical altercation in the parking lot of the motel. The encounter escalated when the accused intentionally drove towards the victim and struck him with the vehicle before fleeing the area. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Michael Lee **BEACH**, was arrested.
