

Solid Waste Disposal Decal Program



Prince William County residents may apply for a “Solid Waste Disposal - Residential User” decal that will allow for faster entry when using the County Landfill, Balls Ford Road Compost Facility, rural park-outs, and the Household Hazardous Waste collection sites. Information on how to obtain a decal is on the reverse side. This decal is not available for commercial users.

We encourage regular residential users of the landfill or other solid waste facilities to obtain and display this decal to facilitate entry. However, a Solid Waste Disposal - Residential User decal is not required and residency can still be established by showing your driver’s license, or the top portion of your personal property or real estate tax bill.

The decal is not transferable and may be revoked if used in violation of the Solid Waste system regulations, including the requirement that the decal not be given to or shared with non-County residents, or commercial users. The decal does not relieve you of any fees that may be applicable. County staff reserves the right to ask for other identification.

There is no charge for this decal and the decal does not expire. No more than 2 (two) decals per address will be issued.

The decal must be permanently affixed to the inside of the vehicle windshield on the driver’s side, within 1” from the left edge and 2-3 inches above the State Vehicle Inspection sticker (see illustration above). Loose or taped decals will not be accepted.

PWC Residents serving in the Military - County Ordinances require all residents to title their vehicle with the Department of Motor Vehicles within (30) days of purchase or move into Virginia and must register within (60) days with Prince William County’s tax office. Vehicles owned by full-time active-duty service members of the United States Army, Navy, Air Force, Marine Corps, Coast Guard & National Guard on active duty for more than 30 days, commissioned officers of the Public Health Service, and the National Oceanic and Atmospheric Administration engaged in active service and spouses may be eligible for Military tax exemption. - Complete this application online and submit.
- Email your name, address, and vehicle license tag number to TaxpayerServices@pwcgov.org.
- Please state that you are requesting a solid waste decal in the body of your message.
