Strangulation *ARREST – On April 15, the suspect identified as Shanna Deniece **FREEMAN**, who was sought in connection to the strangulation reported to have occurred at a residence located in the 13500 block of Getty Ln in Woodbridge (22192) on March 25, was arrested.

Strangulation [Previously Released] – On March 27 at 3:31PM, officers responded to investigate an assault that was reported to have occurred at a residence located in the 13500 block of Getty Ln in Woodbridge (22192) on March 25 at approximately 5:00PM. The investigation revealed a family acquaintance, identified as the accused, placed her hand around the neck of the victim, a 4-year-old girl, and lifted her off the ground. The parties separated and the victim notified a family member of the encounter. Minor injuries were reported. Following the investigation, officers obtained an arrest warrant for the accused, identified as Shanna Deniece **FREEMAN**. Attempts to locate the accused were unsuccessful.

Attempted Malicious Wounding (Domestic) *ARREST – On April 13, the suspect, identified as Sartisha Elexus **CARTER**, who was sought in connection to the attempted assault that was reported to have occurred at the Bayvue Apartments located in the 1300 block of East Longview Dr in Woodbridge (22191) on March 24, was arrested.

Attempted Malicious Wounding (Domestic) [Previously Released] – On March 24 at 5:37PM, officers responded to investigate a domestic dispute that was reported to have occurred at the Bayvue Apartments located in the 1300 block of East Longview Dr in Woodbridge (22191) earlier that afternoon. The investigation revealed the victim, a 31-year-old man, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused retrieved a knife leading to a struggle before both parties fell to the floor. When the accused retrieved a larger knife, the victim left the apartment. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Sartisha Elexus **CARTER**, who remains wanted.

Stabbing Investigation – On April 15 at 4:26PM, officers responded to the 8300 block of Sudley Rd. in Manassas (20109) to investigate a stabbing. Once on scene, officers located an 18-year-old man suffering from a cut to his hand. The man was transported to an area hospital with non-life threatening injuries. When officers checked the 10200 block of Irongate Way, where the incident reportedly took place, no evidence of a stabbing was located. The man refused to cooperate further with detectives regarding the incident. **Anyone with information that could aid investigators in this investigation are asked to contact police.**

Stabbing Investigation – On April 14 at 10:27AM, officers responded to the 2900 block of Dale Blvd. in Woodbridge (22193) to investigate a stabbing. The investigation revealed the victim, a 21-year-old man, was approached by an unknown man, who stabbed the victim in the lower back before fleeing. The victim was treated at an area hospital for a non-life threatening injury. A police K-9 searched the area for the suspect who was not located. No additional injuries or property damage were reported.

Suspect Description:

A black male who was approximately 6'0'

Last seen wearing a ski-style mask, a camouflage jacket, and dark-colored pants

Aggravated Assault – On April 6 at 9:50PM, officers responded to a residence located in the 3100 block of Burbank Ln. in Woodbridge (22192) to investigate a shots fired call. The investigation revealed the victim, a 34-year-old woman, was on the back patio of a residence when a round was fired and struck the victim in the upper body. Officers located damage to a tarp and a pellet fragment on the patio. The weapon used was believed to be a BB or other pellet-type gun. No additional injuries or property damage were reported.
