RE: ADOPT FISCAL YEAR 2025 REAL ESTATE PROPERTY TAX LEVY, FIRE LEVY, PERSONAL PROPERTY TAX LEVIES, BUSINESS, PROFESSIONAL, AND OCCUPATIONAL LICENSE TAX LEVIES, MOTOR VEHICLE LICENSE TAX LEVIES, PERSONAL PROPERTY TAX RELIEF, SPECIAL DISTRICT LEVIES, AND PARKS AND RECREATION FEES TO SUPPORT THE FISCAL YEAR 2025 ALL FUNDS BUDGET

ACTION: APPROVED

WHEREAS, the public hearing regarding the Fiscal Year 2025 real property tax levy was duly advertised on March 14, 2024, and held on April 9, 2024; and

WHEREAS, the public hearings regarding the remaining Fiscal Year 2025 tax levies were duly advertised on March 28 and April 4, 2024, and held on April 9, 2024, and the public hearings regarding the Parks & Recreation fees were advertised on March 28 and April 4, 2024, and held on April 9, 2024;

NOW, THEREFORE, BE IT RESOLVED that the Prince William Board of County Supervisors hereby adopts the real estate tax rate of \$0.920 per \$100 of assessed value as the Fiscal Year 2025 (Tax Year 2024) real property tax levy;

BE IT FURTHER RESOLVED that in compliance with Titles 58.1 and 27, VA Code Ann., the Prince William Board of County Supervisors hereby adopts the fire levy rate of \$0.0720 per \$100 valuation for Fiscal Year 2025 (Tax Year 2024) on all real estate and restricts these funds for fire and rescue purposes;

BE IT FURTHER RESOLVED that the Prince William Board of County Supervisors hereby adopts the following Fiscal Year 2025 (Tax Year 2024) special levies at a rate per \$100 valuation on all real estate and restricts these funds for the special levy districts as follows:
