### Patrick Kincheloe and Nancy Clutz - The Untold Story

[A branch of the Kincheloe family in Prince William County has a mysterious past. Researchers have been unable to link ancestor Patrick Kincheloe (born ca. 1800-10) with any earlier member of the prolific colonial family of that name, despite several serious attempts. Patrick's wife Nancy Clutz also is a puzzling figure. Contemporary documents found by Ms. Thompson throw some light on the relationship between Patrick and Nancy, and lead to the discovery of Nancy's true origins.]

While researching my family, my Aunt Josephine (Davis) Thompson (an aunt by marriage) proved to be a source of information on the Thompsons. Aunt Josephine – everyone called her Josey – was married to my father's brother Elbert. She told me about ancestors who died long before I was born - my grandparents, aunts, uncles and cousins. She told me many things that can't be found in any public record or as some might say old fashioned gossip.

Aunt Josey was 85 at the time when I realized that I didn't know anything about her family. She told me that when she was three, after her mother Katie (Fairfax) Davis died, she went to live with her grandparents, Henry Baines Fairfax and Annie Mariah (Kincheloe) Fairfax at Hoadly in Prince William County. That was the first time I heard the name Hoadly.

When I asked her where was Hoadly, she said near the baseball stadium. That told me that somewhere in Prince William County was a baseball stadium and near the stadium was Hoadly. I am proud to say I now know where to find Hoadly, in fact I have been there. In the Spring of 2003 with Howard Thompson (not related) my guide, and Doug, Josey's son, we made our way into the woods to the home site of Henry and Annie Maria Fairfax and to the Fairfax family cemetery where Henry and Annie Maria, their daughter Katie Fairfax Davis, and son, Raymond Fairfax are buried. There are only

two tombstones, and Henry Baines Fairfax's tombstone was the only one standing. Even though Henry died 84 years ago I was able to read his name, when he was born – April 19, 1848, and when he died – January 22, 1919.

Since Aunt Josey didn't know much about her family, I became curious about how her Fairfax line fit in with Lord Fairfax and if her Prince William County Kincheloes were connected to the Kincheloes in Fairfax County. Researching her Kincheloe line was a real challenge. [Note: The Fairfaxes are not traced in this article. / DLW]

The Prince William County census is where I ran into the first of many confusing pieces of information about the family of Annie Maria Kincheloe. I found Annie Maria's parents, Patrick Kincheloe and Nancy together in the same household in the 1850 and the 1860 Prince William County census.

Looking at the census I wasn't sure if Patrick and Nancy were married since she didn't use his surname.

Nancy's first husband was George Clutz who is said to have died at the Alamo. George and Nancy's two children, Mary and Lucretia, were living with Nancy and Patrick in 1850. Since George was Annie Maria's stepfather, I didn't continue to search for more information about George.

Patrick Kincheloe is missing from the Prince William County 1870 census and in fact I didn't find many Prince William County documents with his name. Besides the 1850 and 1860 census, he also appeared in the personal property tax lists from 1855 until 1866, and was mentioned in the 1854 Prince William County Death Register. I used the Prince William County Personal Property Tax Lists as a way to figure out when Patrick died. The 1866 tax year is the last time Patrick's name is listed; therefore it appears that Patrick died around 1865 or 1866.

The 1870 Prince William County Census lists Nancy Cluts as head of the household and Andrew Cluts, Eli Cluts, and Ann M. Cluts, as living in the same household with their mother. Missing from the 1870 Prince William County Census are two of Nancy's sons, James and Edward. I found Edward living in Loudoun County with Thomas and Ann Haws the parents of his wife Lydia. They were married in Washington, D.C., on June 3, 1860. Edward and Lydia's last name in the 1870 census was one of the many spelling variations of Kincheloe – *Kinchlow*.

I did some more searching to find out if Patrick and Nancy were married. In August of 1854, the death of a little girl, Susanna Clutt, age 1 year and 6 months, is recorded in the *Prince William County Death Register*. *Parents*: Nancy Clutts. *Informant and Head of Household:* Patric Kincheloe. [Just below the images from the register is the transcript from a similar record by Ron Turner, which shows variant spellings.]

This is an indenture dated October 9, 1851, between Eli Petty of Charles County, Maryland and *Nancy Ann Klutts*. She paid \$75 for 39 acres on Powell's Creek. This note was written in the margin "examined & delivered to Mr. P. Kincheloe 6/1/1853".

When I couldn't find anything about Patrick Kincheloe's life before 1850, I turned to the Internet to see if I would have better luck finding something about Patrick. A Kincheloe family descendant in Texas put me in touch with John Kincheloe at Meredith College, North Carolina. John wasn't familiar with this Patrick Kincheloe.

I sent John the information I had found on Patrick. In a 1997 e-mail from him, he felt that Patrick was a 19th century immigrant who came on a ship sometime between 1800 and 1845. Patrick's birthplace recorded in the Prince William County 1850 and 1860 Census is Ireland. His surname was not spelled K-i-n-c-h-e-l-o-e until Patrick settled in Prince William County. If I wanted to search for Patrick in shipping records, he suggested that I look for Patrick with a Kinsela, Kinsella, Kinshela, Kinshella, Kensela, Kensella, Kenshela, Kenshela for his last name instead of Kincheloe.

There had been a Kincheloe family in Prince William County since the 1720s, descendants of a Cornelius Kincheloe who came to Virginia, probably from Ireland, by 1693. Attempts to fit Patrick into this family have been unsuccessful. Now there seemed to be considerable doubt that Patrick was related to others of the Kincheloe family in Prince William and Fairfax Counties. I decided that this would be a good place to end my research on Patrick and concentrate on the descendants of Patrick and Nancy.

With so many variations of Kincheloe and Clutz, my research was slow, difficult and frustrating. Even Annie Maria Kincheloe's names had a number of

spellings: Anna M., Mariah, Maria. There were many times that I came close to quitting but I would find another piece of information. I became fascinated by this family. Researching the family members was better than reading a mystery novel because they were real people. I learned from researching this family to have an open mind when looking for surnames. Nancy appeared in the Land Tax Lists as Nancy Klutts, and as Nancy Clutts in the Personal Property Tax Lists in the same year.

Since I wasn't finding any documentation to convince me that Nancy and Patrick were married, I wanted to find out more about Nancy. I thought it would help my research if I knew the correct spelling for Clutz. In the May 1990, issue of the *Newsletter of the Prince William County Genealogical Society*,

an article names Nancy's parents as William Appleby and Naoma Keys.<sup>2</sup> The Prince William County 1860 Census annotated by David Turner and the 1870 Prince William County Census annotated by Ronald Ray Turner both show William Appleby and Naoma Keys as Nancy's parents. [They apparently used the *Newsletter* article as their source / DLW]

I sent for a copy of the Death Certificate for Annie Maria Kincheloe Fairfax. Annie Maria died on December 5, 1926 in King George County, Virginia. **Father's name**: James P. Kincheloe, born in Ireland. **Maiden Name of Mother:** Nancy Petty.

Now I had another research problem. Since Petty was Nancy's maiden name, there was considerable doubt that William Appleby and Naoma Keys were Nancy's parents. I felt that the death certificate had the correct information but I wanted to find some more documentation about Nancy's parents. I learned the importance of documentation from my friend Tom when I first started researching my family. [Note: A death record is not a primary source for the parentage of the decedent, but it is direct evidence of the knowledge of the person giving the information. / DLW]

I found a court case in the book *Implied Marriages of Fairfax County, Virginia*, Cornwell vs. Nelson (1838), CFF [Chancery Final File] #13g.<sup>3</sup> At the Fairfax County Court Archives, I was able to look at the original documents from that case. This court case named the children of Jesse and Constance (Calvert) Cornwell – Kitty King; Nancy Cornwell married Nehemiah Brockley; Lydia Cornwell married Cornelius Hooff; Catherine Cornwell married William (aka Eli Petty) and then John Appleby. In a deposition taken on September 18, 1838, in Brentsville, Nancy *Clutts* answers a question about her grandmother, Constance Cornwell, wife of Jesse Cornwell. Constance was the daughter of Humphrey Calvert.

Since I knew that there was more than one way to spell Clutz, I could have missed this importance piece of information about Nancy: Nancy *Kluks* died on December 18, 1881 age 71 of paralysis. She was the daughter of **Catherine Pettie**. This information was recorded in the 1881 *Prince William County Death Register*. <sup>4</sup>

Finally I had three good sources of information that Nancy's parents were William (aka Eli Petty) and Catherine Cornwell and not William and Naoma Appleby.

In Prince William County Deed Book 33, on page 382, is an indenture dated July 17, 1882 between Nancy Kluts' heirs: John L. Kindslow, wife Martha; E. T. Kindslow, wife Lydia; J. W. Kindslow, wife Charlotte; A. J. Kindslow, wife Margaret; Henry B. Fairfax, wife Annie; of Prince William County & Mary Hunt, wife of Samuel of Washington, DC, and Eli Kinslow. Even after her death in 1881, she is still known as Nancy Kluts not Nancy Kincheloe.

Surviving children of Patrick Kincheloe and Nancy Klutts:

- 1. Edward T[homas] Kinslow married Annie Hawes on June 3, 1868, in Washington, D.C.<sup>5</sup>
- 2. James W[illiam] Kinslow married (1) Lizzie Fountain on 22 December 1869, in Washington, D.C.<sup>6</sup> The marriage of James W. Kincheloe and Lizzie Kincheloe was dissolved on 15 October 1873, in Prince William County.<sup>7</sup> Lizzie was to resume using her maiden name. James W. Kincheloe was

married (2) to Charlotte Cornwell, 25 December 1873, in Prince William County.<sup>8</sup> A copy of James and Charlotte Cornwell's marriage license shows Henry and Mariah Fairfax witnessed their marriage. Ron Turner's transcript of the license he found at the court house shows the parents of James W. Kincheloe as Patrick and Nancy Kincheloe.9

- 3. Anna M. Kindslo married Henry Fairfax on 24 December 1872, in Washington, D.C. 10 Henry and Anna M. are my Aunt Josephine's grandparents. She lived with them after her mother died.
- 4. John Luther Cluts married Martha Jane King on 30 January 1868 in Prince William County. In the marriage register the father's name is blank, and the mother is given as Nancy A. Cluts. 11 Two years after they were married John and his wife Martha are listed in the 1870 Prince William County census as John L. and Martha Kincheloe. 12 At the time John Luther's will was written (August 4, 1896) he was using Kincheloe instead of Clutz. 13
- 5. Andrew [Jackson] Kincheloe married Margaret Tobin on 24 March 1877 in Prince William County. 14
- 6. Levi [i.e. Eli] Kindslow married (1) Eliza Story on 14 Nov. 1882 in Washington, D.C. 15 Eliza Kinslow died 16 October 1892, age 29 years, beloved wife of Eli Kinslow. She is buried at Congressional Cemetery, in Washington, D. C. 16 Eli Kinchloe's planned marriage to Mary Thorburn was announced in the Fredericksburg, Virginia, newspapers in October 1893.<sup>17</sup>

Even though I had so many spelling variations that complicated my research I was able to find information on this interesting Prince William County family by not limiting my research to only one spelling but all of the variations and by being thorough and persistent and examining varied resources from the entire metro area.

[A future article by Donald L. Wilson, RELIC's Virginiana librarian, will continue the search for Patrick Kincheloe's origins.]

# VOTING RECORDS OF WATERFALL PRECINCT, GAINESVILLE DISTRICT 1902-1947

Mount Atlas is one of the older homes in Prince William County, built on Bull Run Mountain, in the vicinity of Waterfall. It was built around 1795. Some owners were Peter B. Whiting, Charles B. Carter, John Hill Carter, John W. and Henry B. Tyler, and Willis Foley. <sup>18</sup> Twentieth century owners were Richard B. Gossom and Elizabeth Owens Smith Gossom who bought it from Mildred Smith. They in turn willed it to their daughter Mrs. Barton Padgett, the former Pauline Gossom.

In 2002, Prince William County was invited to uncover anything of historical value from the house. The house yielded many items that were personal belongings of the Gossoms. Richard B. Gossom had been involved with elections as registrar and judge from at least 1917 to 1929 which explains why the following papers were found in this house. The following items were given to RELIC from the County's Planning Office for safe keeping and will be a part of the Manuscript Collection at Bull Run Regional Library.

### **DIARY OF CRAWFORD CUSHING, 1873**

Grandfather of Katie (Cushing) White Prince William County, Va.

Transcribed by Beverly R. Veness From an extract prepared by E. R. Conner III

[Crawford Cushing (1824-1908) was a resident of Catharpin in Prince William County and served as Gainesville District Supervisor (1870-83, 1884-86). He is buried at Sudley United Methodist Church. This diary, which reveals his close ties to the church, was copied from the original owned by Katherine Cushing White, Warrenton, Va. It "was found in an outbuilding at the Wilkins home near Sudley Church." Crawford Cushing, was the great, great grandfather of E.R. Conner III who gave this transcript to Prince William Library ca. March 1983. It appears to contain selective entries from the diary, primarily of interest for the church's history.]

# Colored Inhabitants of Prince William County, Virginia as Shown in the 1865 and 1866 Personal Property Tax Lists

#### Abstracted by Charlotte Cain

In Virginia in 1865 and 1866, for the first time, all male Negroes over the age of 21 were identified by name in the Personnel Property Tax Lists. This is the first official document to give a list of both the former slaves and free Negroes of Prince William County. Made nearly five years before the 1870 census, this list can give an indication of where former slaves lived prior to their heading to new places such as Tennessee, Baltimore, Pennsylvania and Washington, D.C.

In 1865, the only charge collected was a 40 cent head tax on white males over age 21. As a result Mr. Storke apparently saw no need to record Negro heads of household.

The 1866 requirement was much more extensive. In addition to a 28 cent head tax on both white and black males over 21, numerous categories of goods were taxed: horses, livestock, carriages, watches, clocks, musical instruments, furniture, gold and silver, crops, ships/boats, investment income, and salaries over \$500. A column counting males over 16 (and under 21) is included as a note.

The names and head counts were abstracted from Personal Property Tax Records, Prince William County, 1860-1868, Library of Virginia microfilm reel 709 (RELIC's copy is labeled reel 14055). William C. Merchant's was the upper district, west of Cedar Run and the Occoquan River. John S. Storke assessed the lower district.

#### POSTAL RATE COSTS - SOME THINGS NEVER CHANGE

From the Journal of the Senate of the United States of America, 1789-1873 TUESDAY, January 14, 1840.

Mr. Roane presented the petition of a number of citizens of Prince William county, Virginia, praying a reduction of the postage on letters; which was referred to the Committee on the Post Office and Post Roads.<sup>1</sup>

#### **DID YOU KNOW?**

March 25, 2006 is the 275th anniversary of the founding of Prince William County.

Prince William County was established by the Virginia General Assembly on March 25, 1731.<sup>2</sup> Under the British calendar of that time, March 25 was New Year's Day. (New Year's Day was moved to January 1 in 1752.)

Prince William County is named for Prince William Augustus (1721-1765), a member of the British royal family. His nephew, George III, was the king whom Americans opposed in the Revolutionary War.

Tobacco p<sup>r</sup> Year, whether the quantity of land was more or less, and further, that the rents he would be entitled to receive from the Pltf and the deft would be precisely the same whether the boundaries of the Defendants lot should be established as the Deft contends or whether the boundaries should be established as the pltf contends they ought to be established. And the said LEE being

asked why would you not be entitled to receive from from [sic] the Pltf more or less rent in either of the events of a Verdict establishing the lines contended for by the Plt or those Contended for by the defend<sup>t</sup>.
