Two Extraordinary Surveys: The 1737 Brent Town and 1824 Bristow Tract Maps




Figure 1: Digital image of the 1737 map (photo by author) Courtesy of Special Collections, University of Virginia Library

A 1737 map², drafted fifty years after the 30,000-acre Brent Town Tract was granted to George Brent, Richard Foote, Nicholas Hayward, and Robert Bristow, illustrated 39 house locations and names of owners and residents, a virtual gold mine for archaeologists and historians (Figure 1).

The south western quarter of the large 1687 grant is in northeastern Fauquier County, with the majority of the tract situated in west Prince William County. Information for the eastern quarter of this patent, commonly called the Bristow Tract (a.k.a. Bristoe), was drafted in an 1824 map³ based on




Figure 2: Northern half of the Bristow Tract in 1824 (photograph by Charlotte Cain)




Figure 3: Southern half of the Bristow Tract in 1824 (photograph by Charlotte Cain)

an 1824 land distribution settlement and is well documented⁴ (Figures 2 and 3). The 1824 map showed the shapes of 54 tracts and the town of Brentsville, as the 7500-acre Bristow Tract was subdivided almost 140 years after it had been patented. No buildings were drawn on the 1824 map, but deed records⁵ revealed the names of many owners, renters, and roads, as well as fence line and creek locations.

As a professional archaeologist, I have conducted several projects at and near the Bristow Station Battlefield. I use the Hunter article for the starting point of my historical research in the area for finding landowner names and basic boundary locations from the 1824 tracts. However, no one had ever ground truthed the 1737 and 1824 maps to a modern map, and an archaeologist needs to know exactly, usually within a few feet, where they are located on the surface of the Earth at any point in time.

To help historic research within the Brent Town Tract and Bristow area, I developed a series of maps relating the cartographic details from both the 1737 and 1824 maps in Adobe Photoshop Elements TM 4.0. Photoshop allows for the importation of digital images and make them opaque so the underlying image can be viewed through a faint image of a second map superimposed over it. The faint image can then be stretched and skewed to align with the underlying layer. As each historic map is stretched and skewed, the common details, as well as the interesting oddities, can be observed and drafted onto a new layer to superimpose on any layer/map imported into the file.




Figure 4: Compilation of the Nokesville, Somerville, and Independent Hill USGS maps

Modern United States Geological Survey (USGS) topographic maps⁶ encompassing the area covering the 1737 map between the western end of Cedar Run and Broad Run were used for the base map for the series. USGS topographic maps are known for accuracy in scaling and for placement of tree stands, fences, buildings, drainages, and other landmarks. Once the images were melded together to form a single base map (Figure 4), I was ready to go.




Figure 5: A black and white facsimile of the 1737 map over the modern USGS map




Figure 6: Modern USGS map information over the 1737 map

Some historic maps can be quite tricky when trying to conform them to modern maps, as the original surveyor may have had mapping errors, misnamed landmarks, or may have simply fabricated information to complete the map. The 1737 map was fairly easy to stretch and skew over the modern USGS map overlay (Figure 5), since Broad Run and Cedar Run were fairly accurate in not only their individual 1737 map configurations, but their relationship to each other as well. In reverse, the information from the modern map was then easily transferred to the 1737 map (Figure 6), showing the common and distinctly different details.

The 18th century surveyors of the Brent Town Tract may have never traveled very far from the creek beds into the interior of the tract as the buildings on the 1737 map are only located along the major drainages, perhaps used for lines of sight for surveying. It is possible, however, also that no one was living in the interior uplands at that time period, something archaeology may be able to prove or disprove over time. Different shapes and sizes of the houses on the 1737 map could suggest differences in social and financial status (Figure 7); i.e. some houses were drafted with two chimneys, some with none.

The configuration of Slaty Run was fairly accurate on the 1737 map, but when compared to the modern location of the creek on the USGS map, it was actually situated further east than it should have been. This could have been the result of a simple mapping error placing a couple of survey turns in the wrong place.




Figure 8: George Brent and Robert Bristow boundary in 1737 and modern times

Probably the most lasting and most easily identified landmarks from the 1737 map are two property boundaries. The boundary line between the Robert Bristow and George Brent parcels has been well preserved in the property boundaries shown in deed records and fence lines for the past 275 years (Figure 8). All of Crockett Road (Route 709) and the west edge of Valley View Park are part of the surviving boundary line between the Brent and Bristow tracts.




Figure 9: George Brent and Samuel Hayward boundary in 1737 and modern times

The boundary line between George Brent and Samuel Hayward has also been preserved much in the same way (Figure 9). Aden Road (Route 646), from Victory Baptist Church on the northwest to just north of Cedar Run on the southeast, represents the majority of this portion of the 1737 map. A small portion of the western boundary of Richard Foot's tract may be represented in the first leg of Foulks Road, extending south of Dumfries/Warrenton Road (Route 606). Except for the stream courses, none of the other survey lines from the 1737 map appear to have been preserved in major modern landmarks.




Figure 10: 1737 map information on the modern USGS map

One of the largest benefits from the map overlays was the ability to identify the locations of the 39 named residences from the 1737 map on the modern USGS map (Figure 10). Nine of the houses from the 1737 map were actually located outside the Brent Town Tracts, more than likely drafted as landmarks or lines of sight during the 1737 survey. The placement of the house sites on the USGS map has already correlated a few locations with known archaeological sites, which will help in future research in the path of construction/development in the Brent Town Tract area.




Figure 11: Map details from the 1824 map on a modern USGS map

Adjusting the 1737 map to the modern USGS then allowed for importation of the cartographic details from the deeds of the 1824 Bristow Tract land distribution⁷. Deedmapper⁸ was used to configure the boundaries of the 54 tracts of the 1824 land distribution to check for accuracies between the 1824 map and the 1824 deeds. Even though some adjustments had to be made, the majority of the tract boundaries conformed to modern fences, roads, and tree lines (Figure 11).




Figure 12: Road locations from the 1824 map on modern map

Vint Hill Road, Bristow Road, and Route 28 are just some examples of the historic road system represented in the 1824 map and deed records that still exists today (Figure 12). Bristow Road




Figure 13: 1824 Brentsville boundaries on modern map

(Route 619) bisected the rectangular parcel set aside for Brentsville, which by 1820, contained the site for the Prince William County Courthouse⁹ (Figure 13).

The overlays of the 1737 Brent Town Tract and the 1824 Bristow Tract onto modern USGS maps was a great success. Land boundaries and house locations and residents from the early 18th century and land tracts from the 1820s were plotted onto modern maps. The digital files will be printed using the original large format scale to use for detailed historic research in northeastern Fauquier County and western Prince William County. Donated copies of the digital maps have been given to the RELIC, the Albert and Shirley Small Special Collections Library at the University of Virginia, and the Geography and Map Division of the Library of Congress in Washington, D.C.

Dr. David C. Cline's Business Ledger 1911-1930

Abstracted by Beverly R. Veness

Dr. David C. Cline was a physician in the Dumfries area from about 1905 until his death on 16 August 1931, at age 63¹. He lived at the Alexander Henderson house in Dumfries with his second wife, Miss Annie G. Keys of Joplin, Va., coming here from Wardensville, West Virginia, where he was born. 2,3 He served the residents not only as their doctor but was active in politics and business (helping to create the Quantico National Bank) and for four years served as acting postmaster of Quantico.⁴ He opened the first Chevrolet dealership in Prince William County and owned the first car in the Dumfries/Triangle area.⁵ His son David loaned his father's day book to the Library of Virginia in 1991 for filming. An interesting note by his son (which was filmed as a part of the ledger) says: "Thank you for accepting this research and gen. material for the Prince Wm. archives. It covers dozens of descendants all over this country. I have been in touch with most of them. Dr. Cline was not much on keeping accounts, as you will see. The book covers people from 1905 to 1931 here in Pr. Wm. David C. Cline."

All names in the ledger were abstracted from the microfilm at the Bull Run Regional Library.⁶ Not all of Dr. Cline's notes about his patients are included, only those thought to be of genealogical or historical interest. Some names only appeared in the index or on the cover sheet where he wrote notations. Names on the inside of the front cover are indexed as IC, the first or flyleaf page is indexed as F, and the page on the reverse of the flyleaf is indexed as RF. Back Cover indexed BC. Some names were only found in the index. It seems Dr. Cline erased the entry in the ledger if he needed the page. When names were spelled differently in the index than in the ledger, I've taken note. As his son wrote, Dr. Cline was not much for keeping books so I had to guess on some years which you will see in brackets. Place names are italicized. The word Obst is the abbreviation for Obstetrics. His standard fee for delivering babies was between \$5 and \$15. Many times he took produce as payment.

Humbly complaining your orator and oratrix's Esme SMOCK & Behethelen his wife, James WIGGINTON and Winifred his wife (which said Behethelen and Winifred are two of the heiresses of the late William M^cDANIEL) and Flora M^cDANIEL Alfred M^cDANIEL and James M^cDANIEL another heiress and heirs of the same William M^cDANIEL deceased all infants under the age of Twenty one Years by the said Esme SMOCK their Guardian and Sophia M^cDANIEL and William M^cDANIEL another heiress and another heir of the said William M^cDANIEL and both infants under the age of Twenty one Years by the said James WIGGINTON their Guardian shew unto your Worships that the said William M^cDANIEL the father of those of your Orators and Oratrix's who are heirs and heiresses as herein before mentioned lately departed this life leaving a Very Considerable real estate undisposed of by will and leaving besides those of your Orators & oratrix's who are his Children as aforesaid, others namely Jane M^cDANIEL Betsy M^cDANIEL and Polly M^cDANIEL all of full age and Narcissa M^cDANIEL Kitty M^cDANIEL & Reuben M^cDANIEL infants under the age of Twenty one Years which last mentioned children are with those named in Your Orators and Oratrix's equally entitled to a proportion of their dec^d father[']s Estate and which last named Children your Orators and Oratrix's pray may be made defendants to this their Bill. [Page 135] That by law the said Widow is entitled to Dower and threatens unless it be assigned to her to keep possession of the Mansion house and the messuage and Tenement thereunto belonging without paying any rent for the same which said Mansion house and Tenement lying in prince William is by far the most considerable part of the said M^cDANIELs Estate[.] But now so it is may it please your Worships that for Want of proper process at Law & because of the Infancy of Many of the said M^cDANIELs Children Shewn in this Bill and of the Want of the Consent of others such assignment of dower cannot be made without the aid of this Worshipful Court. William McDANIEL decd which was made out by the Surveyor of the County [Page 138] under our direction and after taking into Consideration the Quality as well as Quantity of said Lands did allott to the defendant Lucy M^cDANIEL Widow of the said William her Dower in the said Lands as included in the platt hereto annexed & marked by figures 1. 2. 3. 4. 6. 10 & 11 Containing One hundred & fifteen Acres and directed the Surveyor to run the dividing line from 10 to 6 so as to include the said Quantity of 115 Acres & return a platt thereof to the Commissioners, in Consequence of which direction the annexed platt was by him returned to Upon Examination we found the platt correct as to course and distance, but it being Suggested to us that the lines were not run & marked as expressed in the platt especially from 10 to 6 we declined making report at that time Whereupon the Court made an additional Order at June Court 1801 in Consequence of which we on the first day of August 1801 met the Surveyor on the premises & directed him to begin at figure 11 & run 100 poles on the dividing line between CANNON & McDANIEL to figure 10 as in the platt expressed : upon running this line we discovered that to the Stake at figure 10 in the platt and report mentioned was two poles Short of the Actual distance This being corrected we proceeded to Run the dividing line So70east 140 poles which we found to differ materially from the former running, tho' we made no Variation in either Course or distance, at the same Time we find that there is no
