#### CSA Division Report – presented by Jessica Webb

 Local use of Rapid Response – The locality has started to work on developing efforts to engage multiple stakeholders to come together when we have high acuity cases where it is difficult to

- identify a placement for a youth. This will mirror the state's efforts and model of the Rapid Response Team.
- Private Day Rate setting The new tiered rate structure has been approved in the state budget and will go into effect on July 1, 2022, with a delayed implementation of July 1, 2023. During FY23, there will be a fiscal impact analysis. Training will be provided to private day providers, local school divisions and local CSA programs.
- Strategic plan update Shaping the Path Committee is regrouping to focus on outcome reporting and ensuring provider accountability. The Access Committee is creating a parent brochure for CSA and the draft will be available soon.
- "Tell Me Something Good" Although there is no specific case mentioned, it is noted that all of the stakeholder agencies go above and beyond to help youth and families in need of services and support.
