Here are some of the most recent operational changes we want you to be aware of:

Applications are also being accepted Monday – Friday at Drop-Off bins and other mail services. Please ensure that all submissions are completed and filled out correctly, and placed in the appropriate bin, as labeled for each agency. We ask that you <u>check the website regularly</u> for any changes to the following instructions:

Address Validation

An address validation is required and can be processed online, only via email to: <u>pwcmaps@pwcgov.org</u>, prior to dropping off your applications. Please allow 24 hours before for your drop off is first processed into our system.

Drop Off Service

Large bins are located outside the Development Service Building Plaza side entrance. There is a bin for each agency.

Plans, permit applications, non-conforming use determinations, rezoning and special use permit case applications may be dropped off.

An address validation, as required, should be submitted with the application.

Prior to dropping off your plans, address validations are processed online only via email. For general inquiries, contact us at 703-792-6840 or by email <u>pwcmaps@pwcgov.org</u> for more information.

If you are dropping off a large volume package, please **email in advance to** <u>DDS@pwcgov.org</u>, so we can promptly receive your applications.

If possible, please place the packages in the sealed envelopes provided.

The bins will be monitored regularly between 8am – 4pm each workday.

Standard mail delivery - Applications are also continuing to be received via US-mail, UPS,

FED-EX.

Credit Card payments to Development Services can now be made via phone at 703-792-6930 and Environmental Services/Watershed via phone at 703-792-7070.

Payments to all other Departments can be made via check, only.

Checks should be made payable to: PWC.

Please ensure all checks are secured to the applications.

Building inspections will continue; however, please note:

For general inspection inquiries, please contact the Inspections Office 703-792-7006 Inspections that require access through an **occupied dwelling** are being suspended for 30 days. (NOTE: Exceptions may be considered for emergencies only (i.e. Power Outages, Structure Fires etc.))

Outside inspections are still being performed as normal.
