- 1. Introductions Mike Garcia
- 2. Small Business Program Wade Hugh
  - a. 491 small businesses have been engaged through the program in the first year
    - i. 379 small businesses have opened through the program
    - ii. 45 small businesses are working through the process
    - iii. 67 small businesses have met with staff for due diligence
  - b. Wade Hugh and Eric Mays provided an overview of the criteria for the Small Business Program
  - c. Wade Hugh announced that George Harben and Ginny Person will be working with Development Services. One of their main duties will be to assist the department with marketing the Small Business Project Management Program.
- 3. <u>Agribusiness/Agritourism Update</u> Wade Hugh
  - a. Wade Hugh attended a meeting on Friday, October 11<sup>th</sup> with the Regional Collaboration Team. One topic discussed by the team was Agribusiness/Agritourism. The team agreed to develop a matrix of various agribusiness/agritourism projects/events. The matrix will enable localities to have an accurate record of the regulatory requirements associated with their neighbors. This will be completed in the next 30 days.

  - a. The team has had three meetings.
  - b. Eric Mays held a training session in August 2019 for the Data Centers
  - c. Sub-Teams will be created to focus on processes and policies
